THIS DEED is dated 3<sup>rd</sup> February 2014

**BETWEEN:**

- (1) **MR ANDREW PAUL TASKER** of 2 Torrington Avenue, Giffnock, Glasgow, East Renfrewshire, Scotland, G46 7LT (Andrew Tasker);
- (2) **AT CONSULT LIMITED**, a company incorporated under the laws of Scotland (registered number SC430597) whose registered office is at 2 Torrington Avenue, Giffnock, Glasgow, East Renfrewshire, Scotland, G46 7LT (the Assignor);
- (3) **VERITAS BIOMED HEALTHCARE LIMITED**, a company incorporated under the laws of Scotland (registered number SC445660) whose registered office is at 2 Torrington Avenue, Giffnock, Glasgow, East Renfrewshire, Scotland, G46 7LT (together with Andrew Tasker and the Assignor, the Assignor Parties); and
- (4) **FONTEM HOLDINGS I B.V.**, a company established and existing in accordance with the laws of The Netherlands (registered number 58467521) whose registered office is at 12th Floor, Barbara Strozilaan 101, 1083 HN Amsterdam, The Netherlands (the Assignee).

**THIS DEED WITNESSES** as follows:

1. In this Deed, a capitalised word or expression not defined in this Deed shall have the meaning given to it in the Option Deed (with references therein to "Purchaser", "Seller" or "Seller Parties" to be substituted for references to "Assignee", "Assignor" or "Assignor Parties", respectively).
2. In consideration of payment by the Assignee of the sum of £ \_\_\_\_\_ (receipt of which is acknowledged by the Assignor), the Assignor hereby assigns to the Assignee with full title guarantee and free of all encumbrances all rights, title and interest in the Trade Marks together with all goodwill associated with the use of the Trade Marks.

3. This Deed shall include all rights and benefits relating to the Trade Marks including (without limitation) the right of the Assignee to bring any action and claim relief in respect of any infringement, passing-off, or other unauthorized use of the Trade Marks whether occurring before, on or after the date of this Deed and the right to claim priority therefrom.
4. The Assignor agrees to promptly sign any documents and to do all other things which the Assignee reasonably considers to be necessary to give effect to this Deed or otherwise to give full effect to the Option Deed as soon as reasonably practicable, including, in the case of any registered Trade Marks (or applications therefor), to enable the Assignee to record their assignment in the records of the relevant registry. The Assignee agrees to pay the costs incurred (from the delivery of the Option Exercise Notice) by the Assignor which are necessary in order to give effect to this Deed.
5. The Assignor shall promptly transfer to the Assignee (or to a nominee appointed by the Assignee) all records, data and information (in any medium) which are in the Assignor's possession, power or control (or those of its professional advisers and agents) and which relate to the Trade Marks as soon as reasonably practicable after the date of this Deed.
6. The Assignor hereby covenants with the Assignee that it will not, without the Assignee's express written authorisation, make any use of any of the Trade Marks.
7. This Deed and any non-contractual obligations arising out of or in connection with it shall be governed by English law. The parties agree that the English courts have exclusive jurisdiction to settle any disputes which may arise out of or in connection with this Deed and that any proceedings arising in connection with this Deed shall be brought to those courts.


