Under Section 904-a of the Business Corporation Law

FIRST: The name of each constituent entity that is to merge is Editure Professional Development Inc., formerly known as Australian United States Services in Education, Inc., a New York corporation ("Editure"), and JBHM LLC, a Delaware limited liability company ("JBHM")

SECOND: The Certificate of Incorporation of Editure was filed by the Department of State of the State of New York on February 11, 1994.

THIRD: The initial Certificate of Formation of JBHM was filed by the Secretary of State of the State of Delaware on August 16, 2012. JBHM has not filed an application for authority with the Department of State of the State of New York.

FOURTH: An Agreement and Plan of Merger has been approved and executed by each constituent entity that is to merge.

FIFTH: The surviving corporation shall be Editure, (the "Surviving Corporation").

SIXTH: The Certificate of Incorporation (the "Certificate") of Editure, as in effect immediately prior to the Effective Time (as such term is defined below), with the exception of Article 1, shall be the Certificate of the Surviving Corporation. Article 1 of the Certificate shall be amended to change the name of Editure and as so amended, shall read in its entirety as follows:

1. The name of the Corporation (the "Corporation") is Generation Ready Inc.

SEVENTH: The effective date of the merger shall be July 31, 2013 (the "Effective Time").


EIGHTH: The merger as contemplated in the Agreement and Plan of Merger between Editure and JBHM (the "Agreement and Plan of Merger") is permitted by the jurisdiction of organization of JBHM and JBHM is in compliance therewith.
