**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of April 15, 2014 (the "Effective Date") by JPMorgan Chase Bank, N.A., (the "Collateral Agent") in favor of Easton Sports, Inc., a California corporation ("Easton" or the "Grantor").

**WHEREAS**, pursuant to the terms and conditions of (i) that certain Revolving Credit Agreement, dated as of December 3, 2009 (as amended and restated pursuant to the Amendment and Restatement, dated as of May 13, 2011), and as further amended, supplemented or otherwise modified from time to time and in effect as of the date hereof, the "Existing Credit Agreement"), among Easton-Bell Sports, Inc., a Delaware corporation (the "Company"), the subsidiary guarantors from time to time party thereto, the lenders from time to time party thereto, the Collateral Agent, as administrative agent and collateral agent, and the other agents parties thereto, (ii) that certain U.S. Pledge and Security Agreement, dated as of December 3, 2009, by the Company, Easton and the other grantors party thereto, in favor of the Collateral Agent (the "Security Agreement") and (iii) that certain Grant of Security Interest in Trademark Rights, dated as of December 3, 2009, by the Grantor in favor of the Collateral Agent, the Grantor pledged and granted to the Collateral Agent, for the benefit of the holders of the Secured Obligations, a security interest and continuing lien in and to all of its right, title and interest in, to and under the Collateral listed on Schedule A attached hereto (the "Released Trademarks"). Each capitalized term used herein without definition shall have the meaning ascribed to such term in the Security Agreement.

**WHEREAS**, pursuant to the terms and conditions of the Existing Credit Agreement and Security Agreement the Grantor has requested that the Collateral Agent release its security interest in the Released Trademarks.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates, cancels, repledges, reassigns and releases any and all collateral pledge, grant, assignment, lien on and security interests it has in and to the Released Trademarks.

If and to the extent the Collateral Agent has acquired any right, title or interest in or to any of the Released Trademarks, it hereby assigns and transfers such rights, title or interest to the Released Trademarks without representation, covenant or warranty, express or implied, and without recourse to it of any kind.

The parties hereto authorize and request the Director of Patents and Trademarks of the United States of America to record this Release against the Released Trademarks. The Collateral Agent hereby authorizes the Grantor to (i) record this Release with the United States Patent and Trademark Office and the Canadian Intellectual Property Office, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of any security interest of the Collateral Agent in the Released Trademarks, and/or (iii) otherwise record or file this Release in the applicable governmental office or agency.

The Collateral Agent shall take all further actions, and provide to the Grantor and each of its respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other


instruments), reasonably requested by the Grantor or the Company, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

This Release may be executed in any number of counterparts, each of which, when so executed and delivered, shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.
