ASSIGNMENT OF TRADEMARK

Assignor does hereby irrevocably assign, transfer, set over, and deliver to Assignee and its successors and assigns, and Assignee hereby accepts, all of Assignor's right, title, and interest in and to the Mark, the registrations thereof and applications therefore, together with (i) the goodwill of the business connected with the use of and symbolized by the Mark, (ii) all causes of actions, claims and demands or other rights for, or arising from any infringement, dilution, unfair competition, or other violation, including past infringement, dilution, unfair competition, or other violation, of the Mark, and (iii) all rights corresponding thereto throughout the world.

2. Assignor agrees, without further consideration, to cause to be performed such lawful acts, and to execute such further assignments and other lawful documents, as Assignee may reasonably request to perfect or record Assignee's right, title and interest in and to the Trademarks.


