**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of April 15, 2014 (the "Effective Date") by U.S. Bank National Association, (the "Collateral Agent") in favor of Easton Sports, Inc., a California corporation ("Easton"), Riddell, Inc., an Illinois corporation ("Riddell"), Ridmark Corporation, a Delaware corporation ("Ridmark"), Equilink Licensing LLC ("Equilink"), a Delaware limited liability company, and Bell Sports Inc., a California Corporation ("Bell", and together with Riddell, Ridmark and Easton, the "Grantors").

**WHEREAS**, pursuant to the terms and conditions of (i) that certain Indenture, dated as of December 3, 2009 (the "Indenture"), among Easton-Bell Sports, Inc., a Delaware corporation (the "Company"), the subsidiary guarantors from time to time party thereto and the Collateral Agent, as trustee, (ii) that certain U.S. Pledge and Security Agreement, dated as of December 3, 2009, by the Company, the Grantors and the other grantors party thereto, in favor of the Collateral Agent (the "Security Agreement") and (iii) (A) that certain Grant of Security Interest in Trademark Rights, dated as of December 3, 2009, by Easton in favor of the Collateral Agent, (B) that certain Grant of Security Interest in Trademark Rights, dated as of December 3, 2009, by Riddell in favor of the Collateral Agent, (C) that certain Grant of Security Interest in Trademark Rights, dated as of December 3, 2009, by Ridmark in favor of the Collateral Agent, (D) that certain Grant of Security Interest in Trademark Rights, dated as of December 3, 2009, by Equilink in favor of the Collateral Agent and (E) that certain Grant of Security Interest in Trademark Rights, dated as of December 3, 2009, by Bell in favor of the Collateral Agent, each Grantor pledged and granted to the Collateral Agent, for the benefit of the holders of the Secured Obligations, a security interest and continuing lien in and to all of its right, title and interest in, to and under the Collateral listed on Schedule A attached hereto (the "Released Trademarks"). Each capitalized term used herein without definition shall have the meaning ascribed to such term in the Security Agreement.

**WHEREAS**, pursuant to the terms and conditions of the Indenture and Security Agreement the Grantors have requested that the Collateral Agent release its security interest in the Released Trademarks.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates, cancels, re-pledges, reassigns and releases any and all collateral pledge, grant, assignment, lien on and security interests it has in and to the Released Trademarks.

If and to the extent the Collateral Agent has acquired any right, title or interest in or to any of the Released Trademarks, it hereby assigns and transfers such rights, title or interest to the Released Trademarks without representation, covenant or warranty, express or implied, and without recourse to it of any kind.

The parties hereto authorize and request the Director of Patents and Trademarks of the United States of America to record this Release against the Released Trademarks. The Collateral Agent hereby authorizes each Grantor to (i) record this Release with the United States Patent and Trademark Office and Canadian Intellectual Property Office, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of any security

interest of the Collateral Agent in the Released Trademarks, and/or (iii) otherwise record or file this Release in the applicable governmental office or agency.

The Collateral Agent shall take all further actions, and provide to each Grantor and each of their respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by any Grantor or the Company, at the applicable Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

This Release may be executed in any number of counterparts, each of which, when so executed and delivered, shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.
