INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (this "Assignment") is made as of July 7, 2008 by and between XTREME METAL FAB INC., d/b/a GO RHINO, a California corporation ("Assignor"), and INDUSTRIA DISEÑADORA DE AUTOPARTES, S.A. DE C.V., a Mexico corporation ("Assignee"), in connection with Assignee's purchase of substantially all of the assets of Assignor.

WHEREAS, Assignor, Assignee and Ron D. Storer ("Shareholder") have entered into that certain Asset Purchaser Agreement dated as of the date hereof (the "Purchase Agreement"). Capitalized terms used but not defined herein shall have the meanings ascribed in the Purchase Agreement; and

WHEREAS, pursuant to the Purchase Agreement and that certain Bill of Sale and Assignment, dated of even date herewith, delivered by Assignor to Assignee, Assignee is acquiring from Assignor the Assets, including without limitation, the issued U.S. and foreign patents, patent applications and trademarks listed on Schedule 1 attached hereto and incorporated by reference herein (the "Intellectual Property").

NOW, THEREFORE, Assignor and Assignee agree as follows:

1. Incorporation of Recitals. The foregoing recitals are incorporated into and made an integral part of this Assignment.
2. Assignment. Effective as of the date hereof, Assignor hereby assigns to Assignee all of Assignor's right, title and interest to the Intellectual Property, including any divisions, continuations or reissues thereof, the same to be held by Assignee for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made; together with all income and royalties now or hereafter due or payable with respect to the Intellectual Property and any and all claims, damages, losses, liabilities and expenses ("Damages") by reason of past infringements of the Intellectual Property, along with the right to sue for and collect such Damages for the use and benefit of Assignee and its successors, assigns and other legal representatives.
3. Subject to Purchase Agreement. This Assignment is made and entered into pursuant to the Purchase Agreement and is subject to the payments, terms, covenants, obligations and restrictions thereof. Assignor makes no representations or warranties regarding this Assignment (or the subject matter hereof) other than as set forth in the Purchase Agreement. In the event of any conflict or inconsistency between the Purchase Agreement and this Assignment, the Purchase Agreement shall control.
4. Further Assurances. The parties covenant that each will, from time to time, execute any documents and take such additional actions as shall be reasonable required in order to more

completely or perfectly carry out the transfer intended to be accomplished by this Assignment.


5. Successors and Assigns. The provisions of this Assignment shall be binding up and inure to the benefit of Assignor, Assignee and their respective successors and assigns.


