**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged,

1. Effective as of October 31, 2013, Assignor hereby sells, assigns, transfers and sets over to Assignee all rights, including common law rights, title, goodwill and interest in and to the Marks, and Assignor agrees that it shall retain no rights to the Marks.

2. Assignor further authorizes the Commissioner of Patents and Trademarks of the United States and any official of any country or countries foreign to the United States whose duty it is to record trademark registration and title thereto, to record the Marks and title thereto as the property of the Assignee, its successors, legal representatives and assigns in accordance with the terms of this instrument.
