RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (the “Release”) is made effective as of April 17, 2014, by BANK OF AMERICA, N.A., as Agent (the “Agent”) to AKORN, INC., a Louisiana corporation (“Akorn”), and ADVANCED VISION RESEARCH, INC., a Massachusetts corporation (“AVR”) (collectively, the “Grantors”, and each individually, a “Grantor”) as follows:

WHEREAS, Akorn, AVR, certain Affiliates of Akorn, the Agent for the Secured Parties, and certain financial institutions are party to that certain Loan and Security Agreement dated as of October 7, 2011 (as may be amended, restated, supplemented or otherwise modified from time to time, the “Loan Agreement”);

WHEREAS, pursuant to the Loan Agreement, the Grantors agreed to execute and deliver a Trademark Security Agreement dated as of October 7, 2011 and October 4, 2013 (collectively the “Trademark Agreement”) to the Agent in order to secure the prompt and complete payment, observance and performance of all of the Obligations in accordance with the terms and conditions of the various loan documents;

WHEREAS, pursuant to the Trademark Agreement, the Grantors granted to the Agent, among other collateral, a continuing security interest in all of the Grantors’ right, title and interest, including goodwill, in, to and under the United States Trademarks listed on the attached Schedule A (the “Marks”);

WHEREAS, the Trademark Agreement was recorded in the United States Patent & Trademark Office on October 13, 2011 at Reel/Frame 4641/0166 and on October 7, 2013 at Reel/Frame 5126/629; and

WHEREAS, the Agent wishes to release its security interest in the Marks.

NOW THEREFORE, as the Grantors have satisfied its Obligations under the Loan Agreement, the Agent hereby terminates, releases and discharges any security interest in and lien upon the Marks, and assigns, transfers, and conveys to the Grantors any and all right, title or interest in, or to, the Marks that the Agent may hold.
