**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

- Security agreement dated June 25, 2010, notice of which was recorded on January 28, 2011 at the United States Patent and Trademark Office at Reel 4463, Frame 0120.

WHEREAS **KinderCare Learning Centers LLC** (f/k/a Knowledge Learning Enterprises, Inc., Mulberry Child Care Centers, Inc. and KinderCare Learning Centers, Inc.), a Delaware limited liability company with its principal office at 650 N.E. Holladay Street, Suite 1400, Portland, OR 97232, entered into the following security agreements with the Collateral Agent:

- Security agreement dated January 7, 2005, notice of which was recorded on January 13, 2005 at the United States Patent and Trademark Office at Reel 3009, Frame 0459; and
- Security agreement dated January 7, 2005, notice of which was recorded on January 13, 2005 at the United States Patent and Trademark Office at Reel 3009, Frame 0488; and
- Security agreement dated January 7, 2005, notice of which was recorded on January 13, 2005 at the United States Patent and Trademark Office at Reel 3009, Frame 0476; and
- Security agreement dated November 9, 2005, notice of which was recorded on November 12, 2005 at the United States Patent and Trademark Office at Reel 3193, Frame 0325; and
- Security agreement dated November 9, 2005, notice of which was recorded on November 12, 2005 at the United States Patent and Trademark Office at Reel 3193, Frame 0318; and
- Security agreement dated June 25, 2010, notice of which was recorded on November 12, 2010 at the United States Patent and Trademark Office at Reel 4415, Frame 0079.

WHEREAS, each of **Aramark Educational Resources, Inc., Children's Creative Learning Center, Inc., KU Champions LLC, Knowledge Universe Education LLC** and

KinderCare Learning Centers LLC, (each, a “Grantor,” and collectively, the “Grantors”) granted the Collateral Agent, under the terms of each the security agreements described above (each, a “Security Agreement,” and collectively, the “Security Agreements”), a continuing security interest (“Security Interest”) in favor of the Collateral Agent, in and to certain of Grantor’s intellectual property, including without limitation the trademarks listed in **Schedule A** through **Schedule E** (collectively, the “Trademarks”) and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, as well as all proceeds and claims based on past, present, or future infringement.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the intellectual property of the Grantors, including the Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, and assigns, transfers and conveys to Grantors any interest in such intellectual property, including the Security Interest and any other liens. The Collateral Agent further hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to the Grantors and their successors and assigns in association with the Security Interest, and hereby releases the Grantors and their successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest.
