RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of April 15, 2014, is made by Rockwell Automation, Inc., a Delaware Corporation, as a secured party (the "**Secured Party**") whose address is 1201 South Second Street, Milwaukee, WI 53204.

WHEREAS, Jacobs Automation, Inc., which was a Delaware corporation whose address was 2365, Progress Drive, Hebron, KY 41048, now Anorad Corporation, a New York corporation, pursuant to an Agreement and Plan of Merger dated as of January 27, 2014 by and between Anorad Corporation, the surviving corporation, and Jacobs Automation, Inc., (the "**Grantor**") had granted a security interest in certain personal property to the Secured Party, including without limitation a security interest in certain trademarks, trademark applications, and trademark licenses, including, without limitation, the trademarks identified on Schedule A attached hereto (the "**Trademarks**");

1. all Trademarks and applications for the Trademarks, together with any registrations, renewals, reissuances, continuations, divisions, and all equivalents thereof throughout the world, and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks; and
2. all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future infringement or dilution of any of the Trademarks, or injury to the goodwill associated with the use of any of the Trademarks.
