THIS AGREEMENT is entered into by and between:

- (1) Respicopea Limited, a company incorporated in the Republic of Ireland with company number 489366 and having its registered office address at 70 Sir John Rogerson's Quay, Dublin 2, Ireland ('**Assignor**').
- (2) Infirst Healthcare Limited, a company incorporated under the laws of England and Wales with company number 08077285 and having its registered office address at 265 Strand, London, WC2R 1BH ('**Assignee**').

INTRODUCTION:

- (A) The Assignor is the proprietor of the trade marks listed in Schedule A ('**Trade Marks**') and the domains listed in Schedule B ('**Domains**').
- (B) The Assignor agreed to assign all its rights in and to the Trade Marks and Domains to the Assignee pursuant to the provisions of the Intellectual Property Assignment and Transfer Agreement dated 31 December 2013.

AGREED TERMS

1. Assignment

Therefore, for good and valuable consideration receipt of which is hereby acknowledged, the Assignor hereby confirms assignment to the Assignee of all rights, title and interest in and to the Trade Marks and Domains and all the rights, powers, liberties and immunities attaching to the Trade Marks, free from all liens, charges and encumbrances, including without limitation any and all common law rights in, and all the goodwill attaching to, the Trade Marks, and the Assignee hereby accepts from the Assignor all rights, title and interest in and to the Trade Marks and Domains.

2. Proceedings

This assignment included the right for the Assignee to bring proceedings against any third party in respect of the Trade Marks (including proceedings against any third party for infringement of the Trade Marks or for passing off or for otherwise

infringing the rights of the Assignor in the Trade Marks whether before the date of this assignment or otherwise).

3. Further Assurance

The Assignor agreed where reasonably required by the Assignee and at the Assignee's cost, to execute such deeds or documents and do such acts or things as may be reasonably necessary to give effect to the assignment agreement signed on 31 December 2013.

4. Law and Jurisdiction

This Agreement will be governed by the law in force from time to time in England and Wales and the parties consent to the exclusive jurisdiction of the Courts of England and Wales.




