**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This RELEASE, dated as of April 17, 2014, is made by UBS AG, STAMFORD BRANCH, as collateral agent (the "Collateral Agent") pursuant to the Credit Agreement and the Security Agreement, dated as of April 30, 2010 (as amended, amended and restated, supplemented or otherwise modified from time to time, (the "Security Agreement"). Capitalized terms used herein not otherwise defined herein shall have the meanings ascribed thereto in the Security Agreement.

WITNESSETH

WHEREAS, Atrium Windows and Doors, Inc. and Thermal Industries, Inc. (the "Pledgors") and the Collateral Agent are parties to the Security Agreement;

WHEREAS, pursuant to the Security Agreement, the Pledgors executed the Trademark Security Agreement (Third Supplemental Filing) dated April 3, 2014 and recorded with the U.S. Patent and Trademark Office on April 7, 2014 at Reel/Frame Nos. 5253/0127 and 5253/0134 (the "Trademark Security Agreement"), pursuant to which, and pursuant to the Security Agreement, the Pledgors granted to the Collateral Agent a lien on and security interest in all of the right, title and interest of the Pledgors in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, pursuant to the Security Agreement, the Pledgors have requested that the Collateral Agent release its security interest on all of its right, title and interest in and to the Trademark Collateral.


NOW, THEREFORE, the Collateral Agent hereby TERMINATES, without recourse the Trademark Security Agreement, and RELEASES, without recourse its security interest and lien on all of its right, title and interest in and to the Trademark Collateral, including the trademark registrations set forth in Schedule I, attached hereto and incorporated herein by reference.

The Collateral Agent agrees to provide the Pledgors with any information and additional authorization reasonably necessary to effect the release of the Collateral Agent's security interest in the Trademark Collateral.


