## RELEASE AND DISCHARGE

- A. The Lender hereby absolutely and unconditionally remises, releases and forever discharges any and all security interests pursuant to the Intellectual Property Security Agreement and authorizes the submission of this Release and Discharge to the Canadian Intellectual Property Office and the United States Patent and Trademark Office in order that the Recordings may be discharged and deleted from the records of the aforesaid trademark offices.
2. This Release and Discharge shall be for the benefit of the Borrower and its successors and assigns and shall be binding upon the Lender and its successors and assigns.
3. This Release and Discharge shall be governed by and construed in accordance with the laws of the Province of Ontario and the laws of Canada applicable therein.
