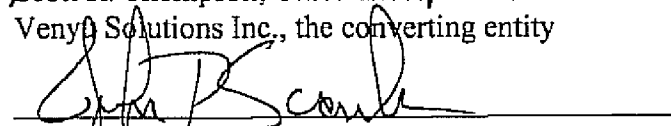
1. The name of the converting entity is Venyu Solutions Inc. The name of the converted entity is Venyu Solutions, L.L.C.

ARTICLES OF ORGANIZATION
OF
VENYU SOLUTIONS, L.L.C.

BE IT KNOWN, that on this 19th day of September, 2013, personally came and appeared before me, the undersigned Notary Public, the persons named below, of the full age of majority, who declared to me, in the presence of the undersigned competent witnesses, that under the provisions of the Louisiana Limited Liability Company Law (Louisiana Revised Statutes 12:1301 et seq.), the undersigned hereby organize a limited liability company pursuant to the following Articles of Organization:

ARTICLE I

The name of this limited liability company is Venyu Solutions, L.L.C.

ARTICLE II

The purposes of this limited liability company are (i) to enter into any lawful business under the laws of the State of Louisiana either for its own account, or for the account of others, as agent, and either as agent or principal, (ii) to enter upon or engage in any kind of business or activity of any nature whatsoever in which limited liability companies organized under the Louisiana Limited Liability Company Law may engage, and (iii) to the extent not prohibited thereby to enter upon and engage in any kind of business of any nature whatsoever in any other state of the United States of America, any foreign nation, and any territory of any country to the extent permitted by the laws of such other state, nation or territory.

ARTICLE III

- A. Limitations on the authority of members to bind this limited liability company will be contained in a written operating agreement.
- B. Subject to the limitations on the authority to be contained in a written operating agreement, this limited liability company shall be managed by managers who need not be members.

ARTICLE IV

- A. The voting rights of the members will be set forth in the written operating agreement.

B. The membership interests in this limited liability company may be evidenced by certificates as provided in the written operating agreement.

ARTICLE V

Persons dealing with this limited liability company may rely upon a certificate of Arthur G. Scanlan, II or John D. Scanlan, each of whom is hereby designated as the certifying official of this limited liability company for all purposes permitted by Louisiana Revised Statutes 12:1305(C)(5), or one or more other members or other certifying officials who are designated in writing by Arthur G. Scanlan, II or John D. Scanlan, or members owning more than fifty (50%) percent interest in this limited liability company, to establish the membership of any member, the authenticity of any records of this limited liability company or the authority of any person to act on behalf of this limited liability company, including but not limited to the authority to take the actions referred to in Louisiana Revised Statutes 12:1318(B).

ARTICLE VI

A. To the maximum extent permitted by law, no member or manager shall have any personal liability for monetary damages for breach of any duty provided in Louisiana Revised Statutes 12:1314 as it now exists or as those duties may hereafter be enlarged. If the Louisiana Limited Liability Company Law is hereafter amended to authorize action further limiting or eliminating the personal liability of members or managers, then the liability of each member and manager of this limited liability company shall be limited or eliminated to the full extent permitted by the Louisiana Limited Liability Company Law as so amended from time to time. Neither the amendment nor repeal of this Article, nor the adoption of any provision of this limited liability company's Articles of Organization inconsistent with this Article shall eliminate or reduce the effect of this Article, in respect of any matter occurring, or any cause of action, suit or claim that, but for this Article, would accrue or arise, prior to such amendment, repeal or adoption of an inconsistent provision.

B. To the maximum extent permitted by law, this limited liability company shall indemnify and hold harmless each member and each manager against all judgments, settlements, penalties, fines and expenses (including attorney's fees and other legal expenses) incurred because it, he or she was a member or manager.

C. Nothing in this Article shall limit or eliminate or provide indemnification for the liability of a member or manager for the amount of a financial benefit received by that member or manager to which it, he or she is not entitled or for an intentional violation of a criminal law.

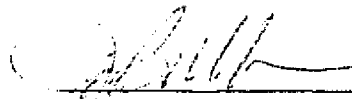
