TERMINATION OF SECURITY INTEREST IN TRADEMARK RIGHTS

THIS TERMINATION dated as of April 24, 2014 ("Termination") is made by THL CORPORATE FINANCE, INC. (the "Agent") under that certain Trademark Security Agreement dated as of August 29, 2013 (as amended and in effect immediately prior to the date hereof, the "Trademark Security Agreement") in favor of NCM CONTRACTING GROUP, LP, a Delaware limited partnership ("NCM Contracting") and NCM Demolition and Remediation, LP, a Delaware limited liability partnership ("NCM Demolition" and, together with NCM Contracting, the "Grantors"). Capitalized terms used but not defined herein shall have the meaning ascribed thereto in the Trademark Security Agreement.

WITNESSETH:

WHEREAS, pursuant to the Trademark Security Agreement, each Grantor granted a security interest to the Agent, for the benefit of the Lenders, in all of such Grantor's right, title and interest in, to and under its owned or thereafter acquired trademarks, including those set forth on the attached schedule (the "Trademark Collateral");

WHEREAS, the Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on August 30, 2013, at Reel 5101 and Frame 0237;


WHEREAS, each Grantor has requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral");

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Lender in the Released Collateral.
