

The undersigned, a natural person eighteen (18) years of age or more, acting as organizer of a limited liability company under the Texas Business Organizations Code, does hereby adopt this Certificate of Formation (this "Certificate") for such entity.

ARTICLE ONE

The company is a limited liability company, and the name of the Company is "SYNCROLITE, LLC." (the "Company"). The Company was originally formed as a limited partnership under Texas law on May 13, 1996, and the address of the Company, as a limited partnership, before its conversion to a limited liability company was 2025 Royal Lane, Suite 370, Dallas, Texas 75229. The Company adopted and approved this Certificate, as provided by Texas law and the governing documents of the Company, as a part of its Plan of Conversion, by which the Company converted from a limited partnership, formerly known as Syncrolite, L.P., to a limited liability company.

ARTICLE TWO

The purpose for which the Company is organized is to engage in any lawful business for which for-profit limited liability companies may be organized under the laws of the State of Texas.

ARTICLE THREE

The address of the initial registered office of the Company is 350 North St. Paul Street, #2900, Dallas, Texas 75201 and the name of its initial registered agent at such address is CT Corporation.

ARTICLE FOUR

The Company will have managers. The Company shall have one (1) manager, and the name and address of the person who shall serve as the initial manager until the next meeting of the members or until his successor is elected and qualified is:

The number of managers of the Company shall be set at one (1) until changed in the manner provided in the Company Agreement.

ARTICLE FIVE

A manager of the Company shall not be personally liable to the Company or its members for monetary damages for any act or omission in his or her capacity as a manager, except to the extent otherwise expressly provided by a statute of the State of Texas. Any repeal or modification of this Article Five shall be prospective only, and shall not adversely affect any limitation of the personal liability of a manager of the Company existing at the time of the repeal or modification.

ARTICLE SIX

The Company reserves the right to amend, alter, change or repeal any provision contained in this Certificate in the manner now or hereafter prescribed by the laws of the State of Texas, and the governing documents of the Company.

ARTICLE SEVEN

This Certificate shall become effective when accepted and filed by the Secretary of State of Texas.


ARTICLE EIGHT
