**TERMINATION AND RELEASE OF SECURITY INTEREST IN  
UNITED STATES TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS (the "*Trademark Termination and Release*") dated as of March 10, 2014, from BANK OF AMERICA, N.A., in its capacity as administrative agent (the "*Administrative Agent*") pursuant to a Security Agreement (the "*Security Agreement*") dated as of April 5, 2013 among SYNARC INC., a Delaware corporation (the "*Company*"), SYNARC A/S, a limited liability company organized under the laws of Denmark, CENTER FOR CLINICAL AND BASIC RESEARCH A/S, a limited liability company organized under the laws of Denmark, SYNARC HOLDINGS, INC., a Delaware corporation (each a "*Grantor*", and together with the Company, collectively the "*Grantors*"), and the Administrative Agent.

WITNESSETH:

WHEREAS, pursuant to the Security Agreement a security interest (the "*Security Interest*") was granted by the Grantors to the Administrative Agent in certain collateral, including the Specified Trademark Collateral (as hereinafter defined); and

WHEREAS, a Notice of Security Interest in Trademarks was recorded in the Trademark Division of the United States Patent and Trademark Office on April 5, 2013 at Reel 4999, Frame 0784;

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Specified Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. Definitions. The term "*Specified Trademark Collateral*", as used herein, shall mean all of such Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks and trademark applications set forth on Schedule I hereto.

2. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges its Security Interest in the Specified Trademark Collateral without representation, warranty or recourse of any kind or nature.

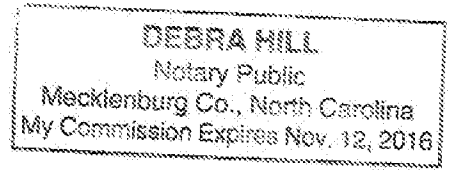
