Assignor hereby requests the appropriate governmental authority to issue any trademark within the Marks to Assignee as Assignee of the Marks as the assignee of the entire interest therein. Upon Assignee's written request, Assignor hereby agrees to execute, at Assignee's expense, such additional form(s) of assignment for the foregoing trademarks and trademark applications as may be reasonably required by the appropriate governmental authority for recordation of this Assignment.


The interpretation and construction of this Assignment shall be governed by the laws of the State of California, excluding any conflicts or choice of law rule or principle that might otherwise refer construction or interpretation of this Assignment to the substantive law of another jurisdiction.

This Assignment may be executed by the Assignor and Assignee in separate and several counterparts, each of which shall be an original, but which together shall constitute one and the same instrument.
