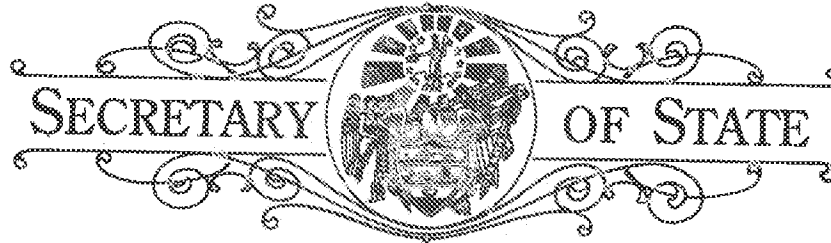

ARTICLES OF AMENDMENT

OF

AISS, INC.

TO THE SECRETARY OF STATE OF THE STATE OF ARKANSAS:

The undersigned, as President of AISS, Inc., a corporation duly organized and validly existing under and by virtue of the laws of the State of Arkansas, hereby desires to amend the Articles of Incorporation to change the name of the corporation pursuant to the Arkansas Business Corporation Act (Act 958 of 1987), and in connection therewith hereby certifies that:

1. The name of the corporation is currently "AISS, INC." and it was duly organized and created, and currently exists under by virtue of the laws of the State of Arkansas.

2. The Articles of Incorporation for AISS, Inc. (f/k/a Acxiom Information Security Services, Inc. and Acxiom Employment Screening Services, Inc.), were filed with the Arkansas Secretary of State on July 29, 2002.

3. The amendment to the Articles of Incorporation to change the name of the corporation to "STERLING INFOSYSTEMS - OHIO, INC." was adopted on July 17, 2012.


4. Paragraph 1. of the Articles of Incorporation is amended to read, in its entirety, as follows:

1. Name. The name of this corporation is "Sterling Infosystems - Ohio, Inc."

5. The amendment was duly adopted and approved by the unanimous consent and vote of the sole shareholder of the corporation.

IN WITNESS WHEREOF, the corporation has caused its corporate name to be subscribed by its President, who verifies that the statements contained in the foregoing Articles of Amendment are true and correct to the best of his knowledge and belief, and who states that he understands that knowingly signing a false document with the intent to file with the Arkansas Secretary of State is a Class C misdemeanor and is punishable by a fine up to \$100.00 and/or imprisonment up to 30 days.
