


RELEASE OF SECURITY INTEREST IN TRADEMARK

Except as expressly provided hereby, all of the terms and provisions of the Trademark Security Agreement, including, without limitation, the continuing security interest, general lien and special power of attorney granted by Grantor to Secured Party with respect to the Trademarks (as defined in the Trademark Security Agreement) other than the Released Trademark and all other collateral relating to the Trademarks other than the Released Trademark, including the goodwill of the business symbolized thereby, are and shall remain in full force and effect


