

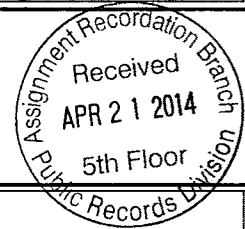

DECLARATION (37 C.F.R. § 2.20)

M. Kathleen Hart, Esq. hereby declares and makes the following statements in support of the above-referenced corrective assignment:

On March 1, 2014, I filed for recordation an assignment of several service marks purportedly being assigned by my client, Innovata, LLC, a Georgia limited liability company, to an affiliate of Innovata, LLC, Innovata IP Holdings, LLC, a Florida limited liability company; the assignment was recorded on Reel 005227, Frame 0842 (the "Original Assignment"). The Original Assignment mistakenly included Registration Number 4081717, INNOVATA, which registered mark was recorded with the PTO as being owned by, and continues to be owned by, Innovata Biomed Limited, a United Kingdom company. The Original Assignment of this registered mark was improper, as Innovata, LLC was not, and never has been, the owner of such registered mark, and therefore, could not assign such mark as set forth in the Original Assignment.

In order to correct the mistake, and with the express authorization of the attorney of record with respect to Registration Number 4081717, I have submitted a corrective assignment for recording, including a new complete cover sheet containing the corrective owner information and submitted on March 4, 2014 (a copy of which is enclosed with this correspondence); this declaration, submitted in response to the PTO's notice of non-recordation dated April 4, 2014 (a copy of which is enclosed with this correspondence); and the required fee of \$40 for the registration to be corrected, submitted on March 4, 2014 (as noted on the cover sheet previously submitted). The current owner of Registration Number 4081717 is Innovata Biomed Limited, which is the last correct owner of such registration and which continues to be the owner of the registration.

I declare further that all statements made herein of my own knowledge are true; that all statements made herein on information and belief are believed to be true; and further that these statements were made with the knowledge that willful false statements and the like are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of this application or document and any registration resulting therefrom.
