PATENT, TRADEMARK AND COPYRIGHT SECURITY AGREEMENT

PATENT, TRADEMARK AND COPYRIGHT SECURITY AGREEMENT (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Agreement"), dated as of August 16, 2013, by and among INCIPIO TECHNOLOGIES, INC., a California corporation ("Borrower"), ORION DISTRIBUTION CORP., a California corporation ("Orion"), and BRAVEN LC, a Utah limited liability company ("Braven"); together with Borrower and Orion, are sometimes collectively referred to herein as "Grantors" and individually as a "Grantor", and U.S. BANK NATIONAL ASSOCIATION in its capacity as administrative agent ("Administrative Agent") for Lenders party to the below-defined Credit Agreement (collectively, "Lenders").

PRELIMINARY STATEMENT

Borrower, Administrative Agent and Lenders are party to a Credit Agreement dated as of the date hereof (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"). Orion, Braven and Administrative Agent are parties to the Guaranty dated as of the date hereof (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Guaranty").

In order to secure each Grantor's obligations under the Credit Agreement, Grantors executed and delivered to Administrative Agent, for the benefit of Administrative Agent and Lenders, that certain Security Agreement of even date herewith by and among the Grantors and Administrative Agent (the "Security Agreement").

Grantors are entering into this Agreement in order to secure their obligations under and in connection with the Credit Agreement, the Guaranty and the other Loan Documents and to induce Lenders to enter into and extend credit to Borrower under the Credit Agreement.

ACCORDINGLY, Grantors and Administrative Agent, on behalf of the Lenders, hereby agree as follows:

1. Definitions. Unless otherwise defined herein, capitalized terms defined in the Credit Agreement shall be applied herein as defined therein. All other undefined terms contained in this Agreement, unless the context indicates otherwise, shall have the meanings provided for by the California UCC to the extent the same are used or defined therein.

2. Grant of Security Interest in Intellectual Property Collateral. To secure the prompt and complete payment, performance and observance of all of the Secured Obligations, each Grantor hereby grants, mortgages and pledges to Administrative Agent, for the benefit of Administrative Agent and Lenders, a security interest upon all its right, title and interest in, to and under the following property, whether now owned by or owing to, or hereafter acquired by or arising in favor of, such Grantor (including under any trade names, styles or divisions of such Grantor), and regardless of where located (collectively, the "Intellectual Property Collateral");

(a) all of such Grantor's Patents (as defined in the Security Agreement) and Patent licenses to which it is a party, including those referred to in Part A to Schedule I hereto;

(b) all of such Grantor's Trademarks (as defined in the Security Agreement) and Trademark licenses to which it is a party, including those referred to in Part B to Schedule I hereto;

(c) all of such Grantor's Copyrights (as defined in the Security Agreement) and Copyright licenses to which it is a party, including those referred to in Part C to Schedule I hereto;

(d) all reissues, continuations or extensions of the foregoing;

(e) all goodwill, trade secrets, proprietary or confidential information, technical information, procedures, formulae, quality control standards, designs, operating and training manuals, customer lists, and other General Intangibles (as defined in the Security Agreement) with respect to the foregoing; and

(f) all products and proceeds of the foregoing, including (i) any and all proceeds of any insurance, indemnity, warranty or guaranty payable to any Person from time to time with respect to any of the foregoing, (ii) any and all payments (in any form whatsoever) made or due and payable to any Person from time to time in connection with any requisition, confiscation, condemnation, seizure or forfeiture of all or any part of the foregoing by any Governmental Authority (or any Person acting under color of Governmental Authority), (iii) any claim of any Person against third parties for (A) past, present or future infringement of any Patent or Patent license, (B) past, present or future infringement of any Copyright or Copyright license, (C) past, present or future infringement or dilution of any Trademark or Trademark license, or (D) injury to the goodwill associated with any Trademark or Trademark license, (iv) any recoveries by any Person against third parties with respect to any litigation or dispute concerning any of the foregoing, and (v) any and all other amounts from time to time paid or payable under or in connection with any of the foregoing, upon disposition or otherwise.

3. Security Agreement. The Lien granted pursuant to this Agreement is granted in conjunction with the Liens granted to Administrative Agent, for the benefit of Administrative Agent and Lenders, pursuant to the Security Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of Administrative Agent with respect to the Liens granted under this Agreement are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.




