ASSIGNMENT OF U.S. TRADEMARKS

NOW THEREFORE, in exchange for the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR HEREBY SELLS, TRANSFERS AND ASSIGNS TO ASSIGNEE: (i) all of ASSIGNOR'S right, title and interest in and to the Trademarks, (ii) all of the goodwill of the business symbolized by and associated with the Trademarks, (iii) all claims against third parties for past, present or future infringement of any of the Trademarks or of the goodwill associated therewith, and (iv) all rights with respect to injury to the Trademarks or the goodwill associated therewith and the right to sue and recover damages for the same.

ASSIGNOR HEREBY AGREES that ASSIGNEE shall have the right to record this Assignment in the United States Patent and Trademark Office so as to establish Assignee as owner of record of the Trademarks.

ASSIGNOR FURTHER AGREES, at the reasonable request of ASSIGNEE and without charge or cost to ASSIGNOR, promptly to: (i) execute and have executed and cause its affiliates to execute any and all other documents of any kind whatsoever, and to provide whatever information may be reasonably required to carry out the terms and intent of this Assignment; and (ii) fully cooperate with ASSIGNEE, as reasonably required, to enable ASSIGNEE to duly record this instrument of assignment with the United States Patent and Trademark Office so that ASSIGNEE'S ownership of the Trademarks is duly made of record. This Assignment shall be binding upon and inure to the benefit of the parties hereto, and their successors and assigns.

ASSIGNOR HEREBY REPRESENTS AND WARRANTS that ASSIGNOR has the full and unencumbered right to sell, assign, and transfer the interests sold, assigned, and transferred herein, and that ASSIGNOR has not executed and will not execute any document or instrument in conflict herewith.
