## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made this 1<sup>st</sup> day of May, 2014 (the "Release Date") by Wells Fargo Bank, National Association, a national banking association ("Wells Fargo"), in its capacity as agent for the Lender Group and the Bank Product Providers (in such capacity, together with its successors and assigns in such capacity, "Agent"), for the benefit of Bomgar Corporation, a Mississippi corporation ("Debtor").

WHEREAS, Debtor and Agent are parties to that certain Credit Agreement, dated as of August 22, 2013 (as at any time prior to the date hereof amended, supplemented or otherwise modified, the "Credit Agreement"), and that certain Guaranty and Security Agreement, dated as of August 22, 2013 (as at any time prior to the date hereof amended, supplemented or otherwise modified, the "Guaranty and Security Agreement");

WHEREAS, in connection with the Credit Agreement and Guaranty and Security Agreement, Debtor and Agent entered into that certain Trademark Security Agreement, dated as of August 22, 2013 (the "Security Agreement"), pursuant to which Debtor granted to Agent for the benefit of the Lender Group and the Bank Product Providers security interests and liens in and to certain assets of Debtor owned at any time prior to the date hereof, including, without limitation, all Trademarks and Trademark Intellectual Property Licenses to which Debtor is a party, including those identified on Exhibit A attached hereto; all goodwill of the business connected with the use of, and symbolized by, each such Trademark and each Trademark Intellectual Property License; and all products and proceeds of the foregoing, including any claim by Debtor against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademarks exclusively licensed under any Intellectual Property License, including the right to receive damages, (ii) injury to the goodwill associated with any Trademark, or (iii) right to receive license fees, royalties, and other compensation under any Trademark Intellectual Property License (the "Trademark Collateral");

WHEREAS, Agent has filed with the United States Patent and Trademark Office (the "USPTO") notices of security interests in the Trademark Collateral at Reel: 005096 and Frame: 0650 on August 22, 2013; and

WHEREAS, Debtor has paid all outstanding amounts currently owing under the Credit Agreement and the other financing documents executed in connection therewith and has requested that Agent terminate and release its interest in the Trademark Collateral.

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby agrees as follows:

1. Release of Security Interest. Effective as of the Release Date, Agent hereby irrevocably and forever terminates, assigns, and discharges any and all security interests in the Trademark Collateral granted by Debtor under the Security Agreement.

2. Recordation of Release. Agent hereby authorizes Debtor or its designee(s) to record this Release with the USPTO.


3. Further Actions. Agent further agrees to execute any other documents and take any further action reasonably necessary in any state, country or jurisdiction that Debtor may reasonably require to effect the intent and purpose of this Release, provided that all such documents are to be prepared by counsel to Debtor and the cost and expense of such documents and actions shall be borne solely by Debtor.

4. Capitalized Terms. All initially capitalized terms used but not otherwise defined herein have the meanings given to them in the Guaranty and Security Agreement or, if not defined therein, in the Credit Agreement, and this Release shall be subject to the rules of construction set forth in Section 1(b) of the Guaranty and Security Agreement, which rules of construction are incorporated herein by this reference, *mutatis mutandis*.
