**PARTIAL RELEASE OF SECURITY INTEREST

Notwithstanding the foregoing, Secured Party does not and shall not be deemed to release or terminate any security interest in or liens upon any Trademarks or other Trademark Collateral of the Company (other than the Specified Trademark Collateral), all of which shall continue in full force and effect, and the release of Secured Party’s security interests and liens upon the Specified Trademark Collateral should not be construed to evidence or reflect the payment or satisfaction of any of the Obligations (as such term is defined in the Trademark Security Agreement) and is without prejudice to the rights of Secured Party to collect any of the Obligations from the Company and/or from any or all of the Trademark Collateral (other than the Specified Trademark Collateral) granted to or held by Secured Party.
