Ownership

1. I, Jerome James Kraisinger, General Counsel & Senior Vice President of Avendra, LLC ("Avendra") declare as follows:
2. This declaration is provided in support of Avendra's Declaration of Use and Renewal application file in Registration No. 2782736 of the mark PREFERRED COMFORT on November 7, 2013.
3. I am currently General Counsel & Senior Vice President of Avendra. I have held my current position since March 31, 2009. I am familiar with all aspects of Avendra's business and have direct knowledge of Avendra's identity as a Delaware limited liability company.
4. Avendra is currently and always has been a limited liability company.
5. Avendra was formed as a limited liability company October 24, 2000. See attached printout from the Delaware Department of State website showing entity information.
6. Since its formation, Avendra never has been a limited liability corporation.
7. At the time the Registration No. 2782736 of the mark PREFERRED COMFORT was acquired from the prior owner, Springs Licensing Group, the transfer documents erroneously listed Avendra as a limited liability corporation, rather than a limited liability company. See attached assignment information obtained from the Trademark Assignment database at Reel/Frame 2910/0564.
8. The assignment subsequently was recorded with the Assignment Branch, erroneously listing Avendra, LLC as a limited liability corporation, rather than a limited liability company.
9. The assignor, Springs Licensing Group, no longer exists, as it was merged into Springs Industries, Inc. and dissolved in 2005. See information obtained from South Carolina corporate database.
10. As the assignor is not available to correct the original assignment document or to execute a new assignment, Avendra requests that its entity designation as listed in Registration No. 2782736 be corrected from "limited liability corporation" to "limited liability company."

11. In accordance with TMEP 503.06(b), Avendra files herewith the following:

 - d. The required fee.

12. Based on the information in this declaration, it is requested that the entity designation of Avendra, LLC in Registration No. 2782736 be corrected to "limited liability company."


WHEREAS, Assignee desires to acquire the Trademark;


