

**CERTIFICATE OF AMENDMENT
TO
SEVENTH AMENDED AND RESTATED
CERTIFICATE OF INCORPORATION
OF
e-REWARDS, INC.**

Pursuant to Section 242 of the General Corporation Law of the State of Delaware, e-Rewards, Inc., a corporation organized and existing under the laws of the State of Delaware (the "Corporation"), does hereby certify as follows:

- I. The name of the Corporation is e-Rewards, Inc.
- II. The Certificate of Incorporation of the Corporation was originally filed with the Secretary of State of the State of Delaware on April 1, 1999. A Seventh Amended and Restated Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on October 25, 2013 (the "Charter").
- III. By written consent of the Board of Directors of the Corporation in accordance with Section 141(f) of the General Corporation Law of the State of Delaware, resolutions were duly adopted pursuant to Section 242 of the General Corporation Law of the State of Delaware setting forth a proposed amendment to the Charter and declaring said amendment to be advisable. The requisite stockholders of the Corporation duly approved said proposed amendment by written consent in accordance with Sections 228 and 242 of the General Corporation Law of the State of Delaware. Such resolutions to amend the Charter are as follows:

The Charter be hereby amended by deleting Section I in its entirety and replacing it with the follow new Section I:

The name of the corporation is **Research Now Group, Inc.** (the "Company").
