**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (the "Release") is executed as of May 2, 2014, by **BANK OF AMERICA, N.A.**, as Administrative Agent for the Secured Parties under the Credit Agreement referred to below (in such capacity, the "Administrative Agent"), in favor of Interactive Data Online Properties, Inc. (f/k/a eSignal, Inc.), Interactive Data Corporation and Interactive Data Pricing and Reference Data, LLC (f/k/a Interactive Data Pricing and Reference Data, Inc.) (the "Grantors"). Capitalized terms used herein and not otherwise defined herein shall have the respective meanings provided therefor in the Credit Agreement referred to below.

WHEREAS, the Grantors entered into that certain Credit Agreement dated as of July 29, 2010 (as amended, amended and restated, or otherwise modified to the date hereof, the "Credit Agreement"), among the Grantors, the Administrative Agent and the other parties thereto; and

WHEREAS, pursuant to the Credit Agreement, the Grantors and the Administrative Agent executed a Trademark Security Agreement dated as of July 29, 2010 (as amended, amended and restated, or otherwise modified to the date hereof, the "Trademark Security Agreement") pursuant to which the Grantors granted to the Administrative Agent, among others, a continuing security interest in all of the Grantors' right, title and interest in and to the United States Trademark registrations and applications listed on Exhibit A hereto, together with the goodwill of the business connected with the use thereof and symbolized thereby, and all rights to sue or otherwise recover for any past, present, or future infringement or other violation or impairment of any of the foregoing (the "Security Interest").

WHEREAS the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 29, 2010 at Reel 004250, Frame 0580.


WHEREAS the Administrative Agent has agreed to terminate and release its Security Interest as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, the Administrative Agent hereby releases, terminates and discharges the Security Interest granted under the Trademark Security Agreement, and any right, title or interest of the Administrative Agent in such Security Interest shall hereby terminate, cease and become void. The Administrative Agent hereby consents to the recording of this Release with the United States Patent and Trademark Office and agrees to duly execute and deliver any further documents and do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
