TRADEMARK ASSIGNMENT



IN WITNESS WHEREOF, ASSIGNOR has duly executed and delivered this Assignment, effective as of the day and year indicated above.



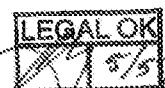
