## RELEASE OF TRADEMARK SECURITY AGREEMENT

May 8, 2014

**WHEREAS**, AESYNT INCORPORATED, a Pennsylvania corporation formerly known as MCKESSON AUTOMATION INC. (the “**Grantor**”), granted to SILICON VALLEY BANK, as Administrative Agent (the “**Assignee**”) a security interest in all of the Grantor’s right, title and interest in, to and under certain Trademarks as set forth in that certain Trademark Security Agreement dated October 31, 2013 by the Grantor in favor of the Assignee (the “**Trademark Security Agreement**”), which was recorded in the United States Patent and Trademark Office on October 31, 2013 at Reel 005143, Frame 0286;

**NOW, THEREFORE**, for good and valuable consideration, receipt of which is hereby acknowledged, Assignee hereby:


1. terminates the Trademark Security Agreement and terminates, releases and reassigns to Grantor any and all liens, security interests, right, title and interest of Assignee pursuant to the Trademark Security Agreement in, to, and under the Trademarks (as defined in the Trademark Security Agreement), including those trademarks identified in **Schedule A** and/or any goodwill associated with any of the trademarks identified in **Schedule A**; and
2. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.

Assignee shall, at Grantor’s expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this release.
