## TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment"), dated as of May 1, 2014, is between C.K.'S SECURITY SYSTEMS, INC., a Florida corporation ("Assignor") and STEVO, INC., a Florida corporation ("Assignee").

WHEREAS, Assignor owns that certain trademark under the name "CK'S LOCKSHOP" applied for with the United States Patent and Trademark Office and assigned Serial No. 86-053,663 (the "Trademark"); and

WHEREAS, for valuable consideration, the receipt of which is hereby acknowledged, Assignor has agreed to assign the Trademark to Assignee and Assignee has agreed to accept and hereinafter own all right, title and interest in and to the Trademark.

Accordingly, the parties agree as follows:

(1) **Assignment.** Assignor hereby assigns to Assignee, its successors and assigns, all of Assignor's rights, title and interest in and to the Trademark, together with the goodwill of the business symbolized by the Trademark, including, without limitation: (i) Assignor's right, title and interest in and to the pending application for registration for the Trademark throughout the world; (ii) all income, royalties, damages and payments now or hereafter due and/or payable under and with respect thereto, including, without limitation, damages and payments for past or future infringements thereof; (iii) the right to sue for past, present and future infringements thereof; and (iv) all rights corresponding thereto throughout the world, as fully and entirely as the same would have been held and enjoyed by such Assignor had this Assignment not been made.


(2) **Further Actions.** Assignor shall execute all documents and take all other actions necessary or reasonably requested by Assignor to assign all the rights, title and interest in and to the Trademark.

(3) **Governing Law.** This Agreement is to be governed by and construed in accordance with the laws of Florida, without regard to its conflict of law principles.


