**TERMINATION OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of May 5, 2014, is made by U.S. Bank National Association, as Collateral Agent for the Secured Parties (together with its successors and assigns, the "Agent") (all terms used but not defined herein shall have the meaning assigned to such terms in the Trademark Collateral Agreement (as defined below)).

**WHEREAS**, Caesars License Company, LLC, a Nevada limited liability company, formerly known as Harrah's License Company (the "Pledgor"), has granted a security interest in certain personal property to the Agent, including without limitation a security interest in certain trademarks and trademark applications ("Trademarks"), pursuant to that certain Trademark Collateral Agreement dated as of June 22, 2010 (the "Trademark Collateral Agreement");

**WHEREAS**, the security interests granted to the Agent were recorded at the United States Patent and Trademark Office as follows: on June 28, 2010 at Reel 4233 and Frame 0195;

**WHEREAS**, the Agent has agreed to terminate and release its security interest in the Trademarks identified on Schedule A attached hereto.

**NOW, THEREFORE**, for valuable consideration, the Agent hereby terminates and releases all mortgages, liens, and security interests granted to the Agent in the following:


1. Pledgor's Trademarks referred to on Schedule A attached hereto;
