

TERMINATION AND RELEASE dated as of May 6, 2014, from JPMORGAN CHASE BANK, N.A., as Administrative Agent (the "Agent"), to IMG WORLDWIDE, INC., an Ohio corporation (the "Company"), IMG WORLDWIDE HOLDINGS, INC., an Ohio corporation, and each of the other entities listed on Schedule I hereto (collectively, the "Grantors"),

WITNESSETH:

WHEREAS, the Company, certain borrowers, lenders and agents and the Agent are parties to the Credit Agreement dated as of June 14, 2010 (as amended, amended and restated, supplemented, or otherwise modified from time to time);

WHEREAS, pursuant to the Guarantee and Collateral Agreement dated as of June 14, 2010 (as amended, amended and restated, supplemented, or otherwise modified from time to time) among the Grantors (as defined therein) and the Agent (the "Security Agreement"), certain of the Grantors, by reference to the Credit Agreement, granted a Security Interest to the Agent in certain collateral, including the Trademark Collateral;

WHEREAS, the Trademark Security Agreement VI was recorded in the Trademark Division of the United States Trademark and Trademark Office on July 21, 2010 at Reel 4246 and Frame 0478;

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of December 23, 2010, among certain of the Grantors and the Agent (the "Trademark Security Agreement VII"), the Grantor (as defined therein), by reference to the Credit Agreement and Security Agreement, reaffirmed its intent to grant and granted a Security Interest to the Agent specifically in certain of the Trademark Collateral;

WHEREAS, the Trademark Security Agreement VII was recorded in the Trademark Division of the United States Trademark and Trademark Office on January 18, 2011 at Reel 4455 and Frame 0631; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest(s) in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Collateral Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the right, title and interest of every kind and nature as of the date hereof in the Trademarks (including, without limitation, those items listed on Schedule A hereto). The term "Trademarks" shall have the meaning provided by reference in the Security Agreement and each of the Trademark Security Agreements.

2. Release of Security Interest(s). The Agent hereby terminates, releases and discharges its Security Interest(s) in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
