TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of April 26, 2013, by GENERAL ELECTRIC CAPITAL CORPORATION, as administrative agent ("Agent") for the Lenders and the L/C Issuers and the other Secured Parties.

WITNESSETH:

WHEREAS, Agent and TIMM MEDICAL TECHNOLOGIES, INC., a Delaware corporation ("**Grantor**") were parties to that certain Trademark Security Agreement dated as of January 20, 2011 (the "**Agreement**") and pursuant to which Grantor granted a security interest to Agent in its trademarks and trademark licenses (the "**Secured Trademarks**") including the Secured Trademarks set forth on Exhibit A hereto; and

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor's right, title and interest in and to all of the following (the "Trademark Collateral"):

- a. all of its Trademarks and all IP Licenses providing for the grant by or to Grantor of any right under any Trademark, including, without limitation, those referred to on Exhibit A hereto;
- b. all renewals and extensions of the foregoing;
- c. all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
- d. all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, warranty, recourse or undertaking Agent, all of Agent's right, title and

interest in and to the Trademark Collateral, and the goodwill of Grantor's business connected with the use of and symbolized by the Trademark Collateral.


