

# AMENDED AND RESTATED CERTIFICATE OF INCORPORATION OF RBS CITIZENS FINANCIAL GROUP, INC.

## Incorporated under the Laws of the State of Delaware November 21, 1984

RBS Citizens Financial Group, Inc., a corporation organized and existing under the laws of the State of Delaware, hereby certifies as follows:

- 1. The date of the filing of its original Certificate of Incorporation with the Secretary of State of the State of Delaware was November 21, 1984 (the "Original Certificate").
- 2. This Amended and Restated Certificate of Incorporation amends, restates and integrates the provisions of the Amended and Restated Certificate of Incorporation that was filed with the Secretary of State of the State of Delaware on January 16, 2003 (the "Amended and Restated Certificate"), and was fully adopted in accordance with the provisions of Sections 242 and 245 of the Delaware General Corporation Law.
- 3. The text of the Amended and Restated Certificate is hereby amended and restated in its entirety to provide as herein set forth in full.

#### ARTICLE I

#### NAME

The name of the corporation is Citizens Financial Group, Inc. (herein the "Corporation").

#### ARTICLE II

#### REGISTERED OFFICE

The address of the Corporation's registered office in the State of Delaware is Corporation Trust Center, 1209 Orange Street, in the City of Wilmington, County of New Castle, 19801. The name of the Corporation's registered agent at such address is The Corporation Trust Company.

#### ARTICLE III

#### **POWERS**

The purpose for which the Corporation is organized is to act as a bank holding company, to act as a savings and loan holding company, and to transact all lawful business for which corporations may be incorporated pursuant to the laws of the State of Delaware. The Corporation shall have all the powers of a corporation organized under said laws.

#### ARTICLE IV

## CAPITAL STOCK

The total number of shares of capital stock ("Capital Stock") that the Corporation shall have the authority to issue is 1,000,000,000 (one billion) shares of common stock, par value \$0.01 per share ("Common Stock") and 100,000,000 (one-hundred million) shares of undesignated preferred stock, par value \$25.00 per share (the "Undesignated Preferred Stock").

#### (a) Common Stock

Except as otherwise required by law or this Amended and Restated Certificate of Incorporation, each holder of Common Stock shall have one vote in respect of each share of stock held by such stockholder of record on the books of the Corporation for the election of directors and on all matters submitted to a vote of stockholders of the Corporation. Except as otherwise required by the Delaware General Corporation Law or as set forth in this Amended and Restated Certificate of Incorporation, the holders of Common Stock shall vote together as a single class on all matters submitted to the stockholders for a vote.

The holders of shares of Common Stock shall be entitled to receive, when, as and if declared by the Board of Directors of the Corporation, out of the assets of the Corporation which are by law available therefore, dividends payable either in cash, in property or in the shares of capital stock.

## (b) Undesignated Preferred Stock

The Board of Directors or any authorized committee thereof is expressly authorized, to the fullest extent permitted by law, to provide for the issuance of the shares of Undesignated Preferred Stock in one or more series of such stock, and by filing a certificate pursuant to applicable law of the State of Delaware, to establish or change from time to time the number of shares of each such series, and to fix the designations, powers, including voting powers, full or limited, or no voting powers, preferences and the relative, participating, optional or other special rights of the shares of each series and any qualifications, limitations and restrictions thereof.

#### ARTICLE V

## **ELECTION OF DIRECTORS**

Election of directors need not be by ballot unless the by-laws of the Corporation so provide.

#### ARTICLE VI

## STOCKHOLDERS' PROPERTY

The private property of the stockholders of the Corporation shall not be subject to the payment of corporate debts to any extent whatsoever.

#### ARTICLE VII

# AMENDMENT OF CERTIFICATE OF INCORPORATION

The Corporation reserves the right to amend this Certificate in any manner permitted by the Delaware General Corporation Law, as amended from time to time, and all rights and powers conferred herein on stockholders, directors and officers, if any, are subject to this reserved power.
