
Assignment of Trademark Application *Nunc Pro Tunc*

7. This Assignment is intended to be *nunc pro tunc* and to be effective as of the date of the Application -- January 19, 2014.

8. This Assignment may be relied on by third parties and is intended to be evidence of the assignment and transfer of the application to be submitted with the trademark assignment form to be filed with the Electronic Trademark Assignment System USPTO.
