- 3. <u>No Warranty</u>. Assignor makes no representations or warranties as to the validity of the Application, the outcome of the Opposition, the eventual registration of the Application in the US Patent and Trademark Office, nor that Assignee's use of the mark TYR will not infringe any third party intellectual property rights, including those belonging to TYR Sports Inc.
- 4. <u>Substitution of Counsel</u>. Assignee agrees that within ten (10) days of execution of this document, it will cause counsel for Assignee to substitute in place of Assignor's legal representative in the Opposition, Alice Carmichael Richey. Assignee further agrees that within

- 6. <u>Filing of Assignment</u>. Assignor hereby appoints Assignee to file and record this instrument with the United States Patent and Trademark Office.


