**ASSIGNMENT OF TRADEMARKS**

THIS ASSIGNMENT OF TRADEMARKS, dated as of April 30, 2013, is made by Goosecross Cellars, a corporation legally organized under the laws of California ("Goosecross"), in favor of AC Vin Co, LLC, a limited liability company legally organized under the laws of Delaware ("AC Vin Co").

WHEREAS, Goosecross owns all right, title and interest in and to the trademarks and registrations thereof identified in the attached Schedule A (the "Marks"), and the goodwill associated therewith;


WHEREAS, pursuant to that certain Asset Purchase Agreement dated April 24, 2013 (the "Purchase Agreement") by and among Goosecross and AC Vin Co, Goosecross has agreed to sell, transfer, convey, assign and deliver, or cause to be sold, transferred, conveyed, assigned and delivered to AC Vin Co, and AC Vin Co has agreed to purchase from Goosecross, all of Goosecross' right, title and interest in and to the Marks and the goodwill associated therewith.

NOW, THEREFORE, in consideration of the mutual covenants and agreements in the Purchase Agreement, and other good and valuable consideration, the receipt of which is hereby acknowledged, Goosecross assigns to AC Vin Co all of its right, title and interest in the Marks as identified in Schedule A, attached hereto and incorporated herein by this reference, together with the goodwill associated therewith including, without limitation, its right to sue for and collect damages for infringement or other violations of the same, including for past infringements or other violations.

This Assignment of Trademarks shall be binding upon and inure to the benefit of the parties hereto and their respective successors and permitted assigns. This Assignment of Trademarks may not be assigned by any party hereto without the prior written consent of the other party hereto, and any purported assignment without such consent shall be void; provided, however, that AC Vin Co may assign its rights hereunder to any affiliate of AC Vin Co (in which case AC Vin Co nonetheless shall remain responsible for the performance of all of its obligations hereunder).



