**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of May 14, 2014, and made by SunTrust Bank, as administrative agent, having an office at 303 Peachtree Street, Atlanta, Georgia 30308 ("STB") to iHealth Technologies, Inc., as Georgia corporation, whose principal place of business is 115 Perimeter Center Place, Suite 700, Atlanta, Georgia 30346 (the "Grantor").

WHEREAS, certain security interests (the "Interests") were granted by the Grantor to STB in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Interests were recorded in the Trademark Assignment Division of the United States Patent and Trademark Office on October 7, 2011, at Reel 004638 and Frame 0127; and

WHEREAS, STB now desires to terminate and release the Interests.

NOW, THEREFORE, for good and valuable consideration, STB hereby states as follows:

1. Definitions. The term "Trademarks", as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto. Capitalized terms used herein without definition are used as defined in the Amended and Restated Guaranty and Security Agreement, dated as of October 6, 2011, made by, *inter alios*, the Grantor in favor of STB.

2. Release of Security Interest. STB hereby terminates the Interests and terminates, releases and discharges its interest in the Trademarks, without recourse, representation or warranty.
