**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of May 14, 2014, and made by SunTrust Bank, as administrative agent, having an office at 303 Peachtree Street, Atlanta, Georgia 30308 ("STB") to iHealth Technologies, Inc., as Georgia corporation ("iHealth"), whose principal place of business is 115 Perimeter Center Place, Suite 700, Atlanta, Georgia 30346, and Ecom PPO Advisors, LLC, a Delaware limited liability company ("Ecom PPO"), whose principal place of business is 8350 North Central Expressway, Suite 600 Dallas, TX 75206 (each iHealth and Ecom PPO a "Grantor", and collectively, the "Grantors").

WHEREAS, certain security interests (the "Interests") were granted by the Grantors to STB in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Interests were recorded in the Trademark Assignment Division of the United States Patent and Trademark Office on May 21, 2010, at Reel 004210 and Frame 0519; and

WHEREAS, STB now desires to terminate and release the Interests.

NOW, THEREFORE, for good and valuable consideration, STB hereby states as follows:

1. Definitions. The term "Trademarks", as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto. Capitalized terms used herein without definition are used as defined in the Guaranty and Security Agreement, dated as of May 20, 2010, made by, *inter alios*, the Grantors in favor of STB.

2. Release of Security Interest. STB hereby terminates the Interests and terminates, releases and discharges its interest in the Trademarks, without recourse, representation or warranty.
