**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Termination"), is dated as of May 14, 2014, and made by Royal Bank of Canada, as collateral agent, having an office at 20 King Street West, 4th Floor, Toronto, Ontario M5H 1C4 ("RBC") to Connolly, LLC, a Delaware limited liability company, whose principal place of business is 50 Danbury Road, Wilton, Connecticut 06897 (the "Grantor").

WHEREAS, certain security interests (the "Interests") were granted by the Grantor to RBC in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Interests were recorded in the Trademark Assignment Division of the United States Patent and Trademark Office on January 29, 2014, at Reel 005203 and Frame 0201;

WHEREAS, RBC now desires to terminate and release the Interests; and

NOW, THEREFORE, for good and valuable consideration, RBC hereby states as follows:

1. Definitions. The term "Trademarks", as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto. Capitalized terms used herein without definition are used as defined in the Security Agreement, dated as of January 29, 2014, made by, *inter alios*, the Grantor in favor of RBC.

2. Release of Security Interest. RBC hereby terminates the Interests and terminates, releases and discharges its interest in the Trademarks, without recourse, representation or warranty.
