**TRADEMARK ASSIGNMENT**

2. Assignor further assigns to Assignee all right to sue for and receive all damages accruing from past, present and future infringements of the Marks.

3. This trademark assignment shall be binding upon Assignor, its successors and assigns and all others acting by, through with or under their direction, and all those in privity therewith.

4. This trademark assignment is given pursuant to that certain Acquisition Agreement by and between Assignor and Assignee and entered into effective as of October 21, 2013 (the “Agreement”), and is subject to the terms thereof. This trademark assignment shall not be construed to amend the terms of the Agreement nor limit, alter, impair, enlarge or enhance the rights thereunder of the parties thereto. This trademark assignment is given solely for the purpose of separately evidencing the transactions contemplated by the Agreement.
