You have requested that Credit Suisse AG, Cayman Islands Branch provide you this release letter (this "Letter").

Credit Suisse AG, Cayman Islands Branch, as First Lien Collateral Agent (the "First Lien Agent"), executed a First Lien Intellectual Property Security Agreement against QMG Acquisition LLC (now known as Questex Media Group LLC), a Delaware limited liability company (the "Debtor"), on December 16, 2009 (the "First Lien"), and recorded said First Lien with the United States Patent and Trademark Office (the "PTO") at Reel/Frame 4117/0489, evidencing and giving notice of the First Lien Agent's security interest in the intellectual property of the Debtor listed therein.

Credit Suisse AG, Cayman Islands Branch, as Second Lien Collateral Agent (the "Second Lien Agent"), executed a certain Second Lien Intellectual Property Security Agreement, by and between the Second Lien Agent and the Debtor, dated as of December 16, 2009, as amended (the "Second Lien"), and recorded same at the PTO at Reel/Frame No. 4117/0566, evidencing and giving notice of the Second Lien Agent's security interest in the intellectual property of the Debtor listed therein.

By execution of this Letter, the First Lien Agent and the Second Lien Agent (collectively, the "Lender") hereby release all security interests in and to the property held under both the First Lien and the Second Lien described in the attached Schedule A, and the Lender and its agents shall be deemed authorized to file this Letter with the PTO evidencing such release and to take all reasonable additional steps as may be necessary to effectuate such release.
