Acknowledgement Of Intellectual Property Collateral Lien

This Acknowledgement of Loan And Intellectual Property Security Agreement is dated as of 5-18, 2014, by SESTUS LLC. ("Grantor"), in favor of Premier Management Associates Limited (the "Lender").

Witnesseth, Whereas, pursuant to that certain Loan and Intellectual Property Security Agreement, dated as of May 17, 2014 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") among the Grantors and the Lender, the Lender has agreed to provide an Advance to the Grantors upon the terms and subject to the conditions set forth therein; and

Whereas, the Grantors granted to Lender certain liens on the Collateral to secure their Obligations under the Security Agreement; and

Whereas, pursuant to the terms of the Security Agreement the Grantors are required to execute and deliver this Acknowledgment in favor of the Lender;

Now, Therefore, in consideration of the premises and to induce the Lender to enter into the Security Agreement and to make loans to the Grantors thereunder, Grantor hereby agrees with the Lender as follows:

Reaffirmation of Grant of Security Interest in Intellectual Property Collateral.


Grantor, as collateral security for the full, prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Obligations of such Grantor, hereby reaffirms its grant of this priority security interest in the Collateral, and further collaterally assigns, conveys, mortgages, pledges, hypothecates and transfers to the Lender, and grants to the Lender, a lien on and security interest in all of its right, title and interest in, to and under the following Collateral of such Grantor (herein referred to as "Intellectual Property Collateral"):

1. the US Copyright Registration titled "Virtual Token source code" and alternatively titled as "PhishCops source code" that is assigned Registration Number TX 7-546-230 and an effective registration date of April 13, 2012;
2. the US Trademark "SESTUS" that is assigned registration number 3,946,787 and that was first registered on April 19, 2011;
3. the US Trademark "VIRTUAL TOKEN" that is assigned registration number 4,156,145 and that was first registered on Feb 10, 2012; and
4. the US Trademark Application "CLOUD TOKEN" that is assigned application serial number 85/599,232 and that was first applied for on Apr 16, 2012.

The security interests reaffirmed herein are granted in conjunction with the security interest granted to the Lender pursuant to the Security Agreement and Grantor hereby acknowledges and affirms that the rights and remedies of the Lender with respect to the security interest in the Intellectual Property Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
