AMENDMENT NO. 1 TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Amendment No. 1 to Intellectual Property Security Agreement, dated as of April 17, 2014 ("Amendment No. 1"), is entered into by and between SkyCross, Inc., a Delaware corporation, with a business address of 42840 Christy Street, Suite 102, Fremont, CA 94538 ("Grantor") and East West Bank, a California banking corporation, with a business address of 9300 Flair Drive, 6th Floor, El Monte, CA 91731 ("Lender").

RECITALS

- A. Grantor and Lender entered into an Intellectual Property Security Agreement dated March 25, 2013 (the "Agreement"); and
- B. The parties hereto wish to further amend the Agreement as hereinafter provided.

AGREEMENT

NOW, THEREFORE, in consideration of the foregoing, the parties hereto hereby agree as follows:

- 1. Terms defined in the Agreement not otherwise defined herein are used herein with the same meanings as in the Agreement.
