**SECOND:** Article FIRST of the Corporation's Certificate of Incorporation is hereby amended in its entirety to read as follows:

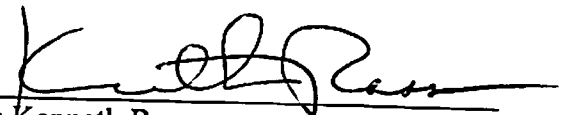
**"FIRST:** The name of the corporation is Global ID Group, Inc."

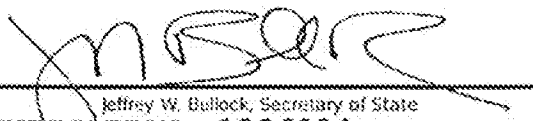
