It was explained that the sole purpose of the meeting was to consider the migration of the Company to Barbados taking into account the following:

**WHEREAS**, the Company was incorporated under the International Business Companies Act 12.1.4 Section 116 on the 5<sup>th</sup> March, 2008 with registered office at 20 Micoud Street, Castries, Saint Lucia, West Indies;

**AND WHEREAS**, it has been resolved that for the better fulfilment of the objects of the Company an application be made under the relevant Laws of Barbados, that the Company continue as an International Business Company under the Laws of Barbados;

**AND WHEREAS**, Section 88 of the International Business Companies Act of Saint Lucia provides that subject to any limitation in the Company's Memorandum or Articles, a company may continue as a company incorporated under the laws of a jurisdiction outside Saint Lucia in a manner provided under those laws;

**AND WHEREAS**, there are no limitations in the Company's Memorandum or Articles that prohibit the Company from continuing as International Business Company under the Laws of Barbados;

**AND WHEREAS**, Section 356.1 of the Companies Act of Barbados also provides that a body corporate that is incorporated in a jurisdiction other than Barbados may, if so authorised under the laws of that other jurisdiction, apply to the Registrar of Companies in Barbados for a certificate of continuance under the Companies Act of Barbados;

**NOW THEREFORE**, it is **RESOLVED THAT** an application be made by the Company pursuant to and in compliance with the relevant Laws of Barbados, for the Company to continue as an International Business Company subject to the Laws of Barbados.

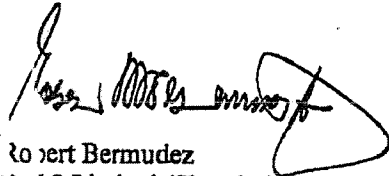
