ASSIGNOR further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Mark, including executing the attached Confirmation of Assignment and causing it to be recorded with the United States Patent and Trademark Office. Assignor shall record the attached Confirmation of Assignment in lieu of recording this Trademark Assignment.


