## TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of May 20, 2014 by **GENERAL ELECTRIC CAPITAL CORPORATION** ("Agent") in favor of **SURFACE GUARD, INC.**, an Illinois corporation (the "Grantor").

### WITNESSETH:

WHEREAS, Agent and the Grantor are parties to that certain Trademark Security Agreement dated as of April 30, 2013 (the "Assignment"), pursuant to which Grantor granted a security interest to Agent in the Trademark Collateral (as defined in the Assignment), including, without limitation, the Trademarks set forth on Schedule 1 hereto (collectively, the "Secured Trademarks"), as security for certain obligations owing by Grantor and certain of its Affiliates to Agent; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on April 30, 2013, at Reel 5017; Frame 0088; and

WHEREAS, Grantor has requested that Agent release its security interest in the Secured Trademarks and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor's right, title and interest in and to the following Secured Trademarks, including, without limitation,:

(i) each trademark and application for trademark listed on Schedule I annexed hereto, together with all renewals and extensions of the foregoing;

(ii) all goodwill of the business connected with the use of, and symbolized by, each such trademark; and

(iii) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Secured Trademarks.

3. Agent agrees, at the Grantor's expense, to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably

requested by the Grantor to affect the release of the Agent's security interest in and lien on the Secured Trademarks.

4. This Trademark Release and Reassignment and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
