**FULL RELEASE OF
TRADEMARK SECURITY AGREEMENT**

THIS FULL RELEASE OF TRADEMARK SECURITY AGREEMENT (this “*Release*”) is made and entered into as of May 20, 2014 by The Royal Bank of Scotland plc, acting in the capacity as Collateral Agent for the benefit of itself and the other Secured Parties (in such capacity, the “*Collateral Agent*”) in favor of VAPORIZER LLC, a Delaware limited liability company (“*Vaporizer*”) and AMERICAN ROCK SALT COMPANY LLC, a New York limited liability company (“*ARS*”, and, together with Vaporizer, the “*Obligors*” and, each, an “*Obligor*”).

Collateral Agent hereby releases its (i) Trademark Security Agreement, dated as of November 27, 2011, (the “*Vaporizer Agreement*”) made between Vaporizer and Collateral Agent, recorded with the United States Patent and Trademark Office at Reel 004941, Frames 0159-0165 and (ii) Trademark Security Agreement, dated as of April 25, 2011 (the “*ARS Agreement*” and, together with the Vaporizer Agreement, the “*Agreements*”) made between ARS and the Collateral Agent, recorded with the United States Patent and Trademark Office at Reel 004528, Frames 0403-0407, each as shown on SCHEDULE A attached with respect to all trademarks and trademark applications including but not limited to those described more fully in the schedules attached thereto and releases, retransfers and reassigns to the applicable Obligor, without representation or warranty (except as set forth herein), all of Collateral Agent’s right, title and interest in and to the such trademarks and trademark applications and the goodwill associated therewith. Collateral Agent hereby terminates, cancels and releases any and all security interests provided by the Agreements.

Collateral Agent agrees to take all reasonable further actions, and provide to the Obligors, its successors, assigns or other legal representatives, all such reasonable cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Obligors to more fully and effectively effectuate the purposes of this instrument.
